***PAIN*T APPROVAL PROCESS**

The process enumerated below is recommended. The only *requirement* is that you submit a completed form and obtain approval prior to painting. The scheme you select must be from those corresponding to your *roof color* in order to be eligible for approval. The **Palomino Paint Binder** is available for your review at the Sherwin Williams store, 5612 West Bell Road, Glendale, AZ (602-978-8771).

1. Obtain a submittal form from our website www.Palominohoa.org or City Property Management (address on above).
2. Obtain your roof color from the Palomino Paint Binder.
3. View the color schemes at Sherwin Williams.
4. Read the General Information sheet in the Palomino Paint Binder.
5. Obtain small containers of the colors you select and paint a 3'X3' or larger patch on an *inconspicuous* area of your home to see what the color looks like on your house. It will differ from the small paint chips you see in the scheme binder because of texture, lighting, and other variables. Paint smaller patches of the pop-out color adjacent to the body color patch. Repeat as often as necessary to find a scheme you like on *your* house.
6. Get bids from painting contractors.
7. Submit a completed copy of this form to CPM.

INCOMPLETE SUBMITTALS WILL BE DENIED

Homeowner agrees to comply with all applicable cities and state laws, and to obtain all necessary permits. Approval by the Architectural Committee shall not be deemed a warranty or representation as to the quality of such construction, installation, addition, alteration, repair, change or other work, or that the proposed work conforms to any applicable building codes or other federal, state or local law, statute, rule or regulation.

Where a permit is required, approval will be given contingent upon the homeowner providing copies of ALL necessary permits by faxing or delivering to City Property Management Company BEFORE beginning construction. Questions regarding permits should be directed to the City of Glendale, Planning and Zoning at (623) 930-2800.

Approved projects shall be completed within three (3) months of onset of work. Approval expires if the project is not completed within six (6) months of the date of approval. In that case, the request must be resubmitted and new approval obtained prior to performing the work.

The Committee shall have sixty (60) days after receipt of the completed Architectural Review Committee Submittal form to approve or deny the request.

The Architectural Committee generally meets the second Monday of each month (see calendar for schedule) and acts only on submittals received at City Property Management by close of business on the Wednesday preceding the meeting date.
